Owners wishing to register their dogs must reside within the City of Perth Local Government boundary, ie:(Crawley, East Perth West Perth, Northbridge or CBD)

This registration is valid unless cancelled pursuant to Section 16 of the Dog Act.

All dog licenses expire on **31 OCTOBER**.

All dogs aged three (3) months and over must be registered.

At all times, dogs must wear a current registration tag, together with an identification disc, with the name and residential address of the owner legibly endorsed or inscribed on or attached to the collar.

Council must be notified immediately if any particulars contained in this application change.

The 50% discount on dog registration fees is applicable **ONLY** to persons issued a current **PENSIONER HEALTH BENEFITS CARD**.

If your dog has been sterilised and you wish to claim the reduced fee, **PROOF OF STERILISATION MUST BE SHOWN**, either by a certificate from a Veterinary Surgeon or by completing a Statutory Declaration Form available from Compliance Services.
