	If you are a nominee you must give the nomination to the local government with this form unless the CEO requires the written notice of the nomination to be incorporated into this form.
	If a corporate body or group of people owns or occupies more than one property in a district, a nomination applies to all of those properties.
<b>Duration of</b>	If you are an occupier and your enrolment eligibility claim is accepted it will expire
